A MESSAGE FROM OUR PATRON

The work that the dedicated team at PTSD Dogs does by rescuing displaced and homeless dogs and supporting veterans and first responders is life changing for all involved.

Before being elected to the Australian Parliament in 2016 I served as a Queensland Police Officer, and I was involved in road crash investigations. My years as a first responder have left a lasting impact and given me an understanding of how PTSD impacts the daily lives of people living with the condition.

Angie and Roger Weeks and their team of trainers, volunteers, and supporters have gained significant recognition for the important work they do. During 2025, the organisation has been a nominee and finalist in the 2025 Kings Trust Awards, Commonwealth Business of the Year Award, and the 2025 Sunshine Coast Business awards – Social Impact category.

In 2025, PTSD Dogs moved to a new property in Cooroibah with a dedicated training shed, agility training area, training sensory garden, and plenty of room for future expansion.

Five dogs have been placed in the last year, including two assistance dogs, two therapy dogs, and one bomb detection dog in training with the Australian Army.

PTSD Dogs have also launched the Train Your Own assistance dog program to support people to train their existing dog to mitigate their anxiety, depression, or PTSD symptoms.

A dog's ability to read emotions and pick up stress signals make them a perfect companion and helper, and trained PTSD Assistance Dogs are making significant and positive differences in many lives.

It has been an honour to support the work of PTSD Dogs Australia, and Angie and her team deserve congratulations on their recognition, achievements, and work in Rescuing Dogs Who Rescue Veterans and First Responders.

- Community at the Core: We are a supportive, inclusive team, dedicated to walking alongside our clients every step of the way.

The Role of PTSD Assistance Dogs

A PTSD Assistance Dog is a lifeline, not just a pet. These highly trained dogs:

- Mitigate the challenges of PTSD and anxiety for people from all backgrounds.

DIRECTOR'S REPORT

A Year of Strategic Growth and Gratitude

It is with deep gratitude and a profound sense of achievement that we present our Director's Report for PTSD Dogs Australia Ltd. Our unique **Rescue First approach** continues to stand as a beacon of hope not only saving dogs, but also delivering measurable and meaningful benefits to individuals, families, and the broader community. This unwavering focus has been the driving force behind our outcomes for the period 2024-2025.

The Bow and Arrow Analogy: Pulling Back to Propel Forward

This year, our strategic direction was inspired by the Bow and Arrow analogy recognising that sometimes one must pull back in order to launch further ahead. It became clear that the Black Mountain property could no longer accommodate our vision for future growth. In response, our Founders, Roger and Angie Weeks, made the pivotal decision to acquire a new property. The acquisition of the **\$2 million Cooroibah property** a sprawling 10 acre site in the heart of the Noosa Shire was both a bold and necessary step. Its central location offers optimal access for community training. Entering the property market at such a competitive time, this purchase represents a significant commitment to our long-term future, prompting us to carefully plan and develop for sustainable expansion.

Focused Effort Amidst Transition

Given the demands of this transition, we made the strategic decision to temporarily **reduce the number of dogs rescued**. This allowed us to provide dedicated support to our current dogs and handlers, while also focusing on critical growth initiatives most notably, the development of our new headquarters and the enhancement of training facilities.

Despite the challenges, our **small yet formidable team** demonstrated unwavering dedication. This collective effort resulted in:

- Installation of air conditioning in the office areas
- Creation of dog safe, securely fenced zones
- A comprehensive facelift for our training shed, with ongoing improvements planned
- Establishment of a shopfront and an information session area, already successfully utilised for future handlers, fosters, and community events
- Installation of a dog wash hydro bath and washing machine, including all necessary electrical upgrades
- A significant expansion of our training space, with the installation of a 24-metre-long by 5-metre-wide Stratco awning on a concrete slab

Innovation and Community Engagement

This year also saw the **launch of the Train Your Own Program**, a vital step in extending our services to more people especially in anticipation of forthcoming changes to National Assistance Dog legislation over the next 12-24 months. Our trainers continue to refine and grow this program, and we are excited about the development of our Training Log App, which, though in its early stages, promises to enhance our services when launched towards the end of 2026.

Education and advocacy remain central to our mission. Our CEO was honoured to serve as a guest speaker at the Australian Events Care Expo, sharing insights and fostering greater community awareness and accessibility for all assistance dog teams.

Looking Back with Pride, Moving Forward with Purpose

The Board is immensely proud of our Pack's achievements and the life changing outcomes witnessed for both our dogs and their handlers. We are truly blessed to observe the positive ripple effects in the lives we touch. To the extraordinary individuals and organisations who so generously contribute their time, energy, and resources we salute you. Our successes are your successes. To our dedicated staff, few in number but mighty in spirit, our heartfelt thanks.

Closing Reflections

In closing, it is through collective resilience, focus, and unwavering effort that our Pack is being propelled into a promising future. 





We have compiled the accompanying special purpose financial statements of PTSD Dogs Australia Ltd, which comprise the balance sheet as at 30 June 2025, the income statement, the statement of cash flows, a summary of significant accounting policies and other explanatory notes. The specific purpose for which the special purpose financial statements have been prepared is set out in Note 1.

The Responsibility of the Directors

The directors of PTSD Dogs Australia Ltd are solely responsible for the information contained in the special purpose financial statements, the reliability, accuracy and completeness of the information and for the determination that the basis of accounting used is appropriate to meet their needs and for the purpose that financial statements were prepared.

Our Responsibility

On the basis of information provided by the directors we have compiled the accompanying special purpose financial statements in accordance with the basis of accounting as described in Note 1 to the financial statements and APES 315 *Compilation of Financial Information*.

We have applied our expertise in accounting and financial reporting to compile these financial statements in accordance with the basis of accounting described in Note 1 to the financial statements. We have complied with the relevant ethical requirements of APES 110 *Code of Ethics for Professional Accountants*.

Assurance Disclaimer

Since a compilation engagement is not an assurance engagement, we are not required to verify the reliability, accuracy or completeness of the information provided to us by management to compile these financial statements. Accordingly, we do not express an audit opinion or a review conclusion on these financial statements.

The special purpose financial statements were compiled exclusively for the benefit of the directors who are responsible for the reliability, accuracy and completeness of the information used to compile them. We do not accept responsibility for the contents of the special purpose financial statements.

Notes to the Financial Statements

PTSD Dogs Australia Ltd For the year ended 30 June 2025

1. Statement of Significant Accounting Policies

The directors have determined that the company is not a reporting entity and accordingly, this financial report is a special purpose report prepared for the sole purpose of distributing a financial report to members and must not be used for any other purpose. The directors have determined that the accounting policies adopted are appropriate to meet the needs of the members.

The financial report has been prepared on an accrual basis and under the historical cost convention, except for certain assets, which, as noted, have been written down to fair value as a result of impairment. Unless otherwise stated, the accounting policies adopted are consistent with those of the prior year.

The accounting policies that have been adopted in the preparation of the statements are as follows:

Inventories

Inventories are carried at the lower of cost or net realisable value. Cost is based on the first-in, first out method and includes expenditure incurred in acquiring the inventories and bringing them to the existing condition and location.

Property, Plant and Equipment

Property, plant and equipment is initially recorded at the cost of acquisition or fair value less, if applicable, any accumulated depreciation and impairment losses. Plant and equipment that has been contributed at no cost, or for nominal cost, is valued and recognised at the fair value of the asset at the date it is acquired. The plant and equipment is reviewed annually by directors to ensure that the carrying amount is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the utilisation of the assets and the subsequent disposal. The expected net cash flows have been discounted to their present values in estimating recoverable amounts.

Freehold land and buildings are measured at their fair value, based on periodic, but at least triennial, valuations by independent external valuers, less subsequent depreciation for buildings.

Increases in the carrying amount of land and buildings arising on revaluation are credited in equity to a revaluation surplus. Decreases against previous increases of the same asset are charged against fair value reserves in equity. All other decreases are charged to profit or loss.

Any accumulated depreciation at the date of revaluation is offset against the gross carrying amount of the asset and the net amount is restated to the revalued amount of the asset.

Intangibles

Goodwill is recognised as the excess of the purchase price for a business acquired over the fair value of the net assets at the date of acquisition. Goodwill is assessed for impairment annually and is carried at cost less accumulated impairment losses.

Trade and Other Receivables

Trade receivables and other receivables, including distributions receivable, are recognised at the nominal transaction value without taking into account the time value of money. If required a provision for doubtful debt has been created.

Financial Assets

Investments held are originally recognised at cost, which includes transaction costs. They are subsequently measured at fair value which is equivalent to their market bid price at the end of the reporting period. Movements in fair value are recognised through an equity reserve.

Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the company that remain unpaid at 30 June 2024. Trade payables are recognised at their transaction price. They are subject to normal credit terms and do not bear interest.

Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held on call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

Revenue Recognition

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Goods and Services Tax

Transactions are recognised net of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the balance sheet.

Grants

Grant revenue is recognised in the income statement when the entity receives the grant, when it is probable that the entity will receive the economic benefits of the grant and the amount can be reliably measured.

If the grant has conditions attached which must be satisfied before the entity is eligible to receive the grant, the recognition of the revenue will be deferred until those conditions are satisfied.

Where the entity incurs an obligation to deliver economic value back to the grant contributor, the transaction is considered a reciprocal transaction and the revenue is recognised as a liability in the balance sheet until the required service has been completed, otherwise the income is recognised on receipt.

PTSD Dogs Australia Ltd receives non-reciprocal contributions of assets from the government and other parties for a nominal or zero value. These assets are recognised at their fair value on the date of acquisition in the balance sheet, with an equivalent amount of income recognised in the income statement.

Donations and bequests are recognised as revenue when received.


